Opening Reflection by the Revd Sarah Gower Convenor of Children and Youth Group

Who am I? Who are you? Who are we?

In exploration of some answers, I wonder what you would reply if I were to ask you some questions.

- Do you have a car?
- Are you right-handed?
- Do you have more than 30 books in your house?
- Is English your first language?

Questions we are probably very happy to answer. Others we might not answer so readily.

- Have you ever had to skip a meal because you didn't have enough food?
- Do you feel safe walking alone at night?
- Have you ever been made redundant or been out of work?



Some of these questions, generally in this country at least, are innocuous. Some are more thought-provoking for us. We will all answer those questions differently, even if we only use 'Yes' or 'No'. If we gave further details, there would be even more differences between our answers. That is what it is to be people, to be human. If I asked the question, 'Are you loved by God?' I might still receive different answers depending on your experience and many other factors. But, actually, there is one answer. Yes, you are – each of you.

In the last few weeks, like us, some of will have been following the lectionary. Delightfully, during this season of Lent, we are in John's Gospel, and we have heard about two people. A scribe of the Pharisees – Nicodemus – and a Samaritan woman whose

name we do not know. One is an upright leader of the Jews who, nevertheless, comes to see Jesus at night. His question to Jesus was, who are you? And how does that affect who he, Nicodemus, is. Importantly, and incredibly among the scribes and Pharisees, Nicodemus was asking questions not to trick Jesus but to find out what he would say. In contrast, the Samaritan woman encounters Jesus in the open. She too is asking questions, and not afraid to do so. She was surprised that Jesus was talking to her, a woman and one from Samaria. She heard what Jesus said immediately; even in these verses, we can sense her excitement and the

transformation to her and her life that a meeting with Jesus had on her. From an upright Jewish official to the traditionally despised and rejected Samaritan woman, Jesus meets with those who come with questions. The questions he loves to answer are the ones that ask 'Who am I? Who are you? Who are we? And whether we are Nicodemus, or the Samaritan woman or you or me, he answers us just the same - in all our differences and they are blessedly many as God has fearfully and wonderfully made us each to be ourselves. He says, 'you are my beloved child. You are part of my family, the family of God.'

Young or old, right or left-handed, from the UK or from elsewhere, the list continues, he says, 'Come. You are my beloved child.' Our identity, our belonging is formed in different ways; ultimately, our place, our belonging, who we are, is held within the loving heart of our amazing and incredible God.

Brothers and sisters, as we travel through Lent, and look to the celebration and joy of Easter, I praise and thank God, that we do so together in all our differences held within the love and family of God.

Meeting of the East Midlands Synod

The **102nd meeting** of the East Midlands Synod took place on Saturday 18 March at St Andrew's with Castle Gate United Reformed Church in the centre of Nottingham, chaired by our Moderator the **Revd Geoffrey Clarke**.

In his Opening Worship, the **Revd Dr Phil Wall** related the anxieties and discomforts of taking a journey to the real fears and backwardlooking of the Israelites in **Exodus 16**, following their escape from Egypt. The **Church Life Review** group, on which he serves, is engaged in "counting quails and managing manna" as it looks to bring options for the



denomination's future to General Assembly. Brave decisions are needed if the URC is to survive and thrive for the sake of the gospel. The guarantee offered by scripture is not that the journey will be easy, but that God will equip us for its challenge.

Synod was formally welcomed to St Andrew's with Castle Gate by its Secretary **Noel Worley**. A gathered congregation formed of several amalgamations, it now serves as Resource Church for the South Notts Area. Post-pandemic, with attendance steadily recovering and some new members, the church is continuing to live-stream worship and is looking to the future with positivity. It has become an Eco Church, registered to host same sex marriages, and is now busy reviewing its Pastorate Profile and development plans.

As Synod moved on to consider **Personalia**, the Moderator highlighted new ministers and first-time attenders for an especially warm welcome. This was followed by a celebration of **Jubilee Ministers and Ordination Anniversaries**, an opportunity to mark the service of 20 ministers who between them account for some 630 years of ministry. Geoffrey was pleased to present certificates in person to those in attendance.

Following our enforced experiments with virtual Meetings as a result of Covid-19, Synod debated the format of its future gatherings. Serving this meeting in her final duty as Synod Clerk, the **Revd Camilla Veitch** asked whether we should retain a place for virtual meetings, which have to an extent enabled larger attendance, or return exclusively to coming together in person? And where we do, should the locations rotate throughout the whole Synod or toward its geographic centre?

Members of Synod debated the options in groups and in plenary before a ballot. Appointed tellers for the day, **David Greatorex**, **Helen Lidgett** and **Irene Wren** returned later to announce that the largest number of votes had been cast for the proposal to alternate virtual meetings with physical ones, centrally located. This will allow Synod staff to plan confidently for the next two years before further review.

On behalf of East Midlands Synod Trust, the **Revd James Breslin** and legal advisor **Catriona Wheeler** presented revisions to its **Policy on Proceeds from the Sale of Buildings and Land**. Following discussion of the new paper, which responds to previous objections while bringing policy into compliance with the stipulations of the Charity Commission, the Resolution was passed.

Now speaking on behalf of St Andrew's with Castle Gate URC, James returned to the lectern to propose a Resolution for General Assembly on the subject of **Support for Churches in Ukraine**. Through his service to the European Region of the World Communion of Reformed Churches, James was aware of the isolation that the small Reformed Churches of Eastern Europe often feel. Based in the South-West of Ukraine and broadly comparable in size to this Synod, our Reformed Church is nevertheless well integrated and its members have played a significant role in the current conflict.

The proposed Resolutions seek first to formalise the URC's greetings to our brothers and sisters in the Transcarpathian Reformed Church and secondly, to determine what help we might give toward reconstruction in the wake of the Russian invasion, remembering the financial aid we ourselves received from the Reformed family following World War 2. Following amendments to bring greater clarity, these were adopted by Synod and will now go forward for consideration by General Assembly.



By way of a good news story, the **Revd Peter Stevenson** outlined a fruitful initiative at **Stamford United Reformed Church**. With internationally celebrated harpist **Eleanor Turner** a member, **Sanctuary** began as an opportunity for members of the wider community to step inside for music and spiritual contemplation, without any prayers, hymns, scripture or preaching. It has become a self-sustaining monthly event, showcasing other musicians and offering a variety of themes for exploration. "But is it worship?" asks the <u>article about Sanctuary</u> in the current issue of **Reform**; it is certainly outreach, welcoming people who would not otherwise cross the threshold to an experience of spirituality and reflection. Where that may lead is in God's hands.

Synod Administrator **Chris Willis** brought the morning's business to a close by reciting the significant list of churches overdue in submitting **Annual Returns**. Synod representatives were also urged to check whether their churches were amongst the even greater number who had yet to file their mandatory **Safeguarding** returns.



After lunch, at which the lemon and lentil soup proved the surprise hit of the day, Synod moved swiftly through essential business such as the approval of the Minutes of its live-streamed meeting of 10 October 2022 and appointments to Synod and to General Assembly. The **Revd Martin Ferris** gave a report on Assembly Executive, where business included the ongoing Church Life Review and the new Marks of Ministry for Elders and the Elders' Meeting. Executive had also reaffirmed its commitment to vocation and whole-of-life discipleship, and heard a challenge from the **Revd Dr Susan Durber** on the URC's relation to church unity, expressing an "ecumenism of the heart".

Next came the screening of a powerful film commissioned by the Legacies of Slavery Task Group. "<u>Telling It</u> Like It Is" takes an uncomfortable look at white privilege in the Church today and the often unacknowledged barriers faced by Black members. Taking inspiration from Jesus as a beacon of justice, it ends with a plea to listen and to act together as the URC strives to become an actively anti-racist church. One of our Synod's Racial Justice Advocates, the **Revd Andrew Mudharara** himself features in the video and responded to Synod members' comments about the surprises, local resonances and call to action that it contains.

Presenting the first of the **Group Reports**, the **Revd Gillian Poucher**, Convenor of **Training and Development**, amplified the request for volunteers from each Area to serve as networkers and help shape what the Synod offers, especially to lay people. The **Revd David Featonby** as Convenor of **Lay Ministries** commended newly revised guidelines about gifts and expenses for Lay Preachers, urging churches to take these seriously and to consult Synod should they struggle to meet them. For the **Children's and Youth Work** Group, meanwhile, the **Revd Canon Sarah Gower** celebrated the appointment of **Richard Knott** as Children & Youth Development Officer.

The report of the **Ordained Ministries and Churches Group** (OMCG) was an opportunity to remind churches to consult Synod if fuel costs were causing them to struggle, and to mark with sadness the decisions to close of **Castle Square URC**, **Wisbech** and **Ermine URC**. Synod joined in prayer to recognise the life and witness of these two churches.

The Moderator commended to churches the practical, specific challenges to churches contained in the report from the **Justice**, **Peace and the Integrity of Creation** group (JPIC) and drew attention to the short video recently published by the national Church & Society team, designed to be shared in local churches as part of the bid for 100% participation in Eco Church: <u>linktr.ee/ecovideo</u>.



Synod Treasurer **David Greatorex** thanked churches for their M&M contributions. A revised mechanism for calculating offers had been adopted as an emergency measure in 2021; at the recommendation of the Finance Group, Synod resolved to make this the basis of our permanent process, effective from 2024 offers. Updates from Property Officer **Geoff Milnes** and Global Partnership Coordinator **Judith North** concluded the Group Reports.



Closing Worship was led by the Moderator, the **Revd Geoffrey Clarke**. Scriptures from **Exodus 17** and **John 4** prompted his reflection on "Empty Buckets, Rocks and Wells". Faith can wear thin: when our own desperation for affirmation or reassurance strains our confidence in God's guidance, our "empty buckets" make us kindred to the Israelites thirsting in the wilderness. But just as God provides them with water from the least likely of places – a rock – we may be humbled by God turning on the taps of grace and goodness from the people or places we have been tempted to write off. It is the least likely of people Jesus asks to quench his thirst in John 4 – the Samaritan woman at the well in Sychar – and it is there that he promises living water in return, such that we need never be desperate again. "Praise be to our God, thirst-quencher and source of hope and healing. Is the Lord among us, or not?" asked Geoffrey in conclusion: "Try a rock. Try a well."



Elders of St Andrew's with Castle Gate assisted in serving **Holy Communion** and the worship included not only an **Act of Remembrance** for those whom the Synod has lost in recent months, but the presentation of a surprise gift to the **Revd Camilla Veitch** in recognition of the many blessings she brought us during her service as Synod Clerk. Press Statement from Churches Together in England

CTE Presidents call for a period of prayer leading up to the Coronation



Presidents of Churches Together in England have today <u>issued a statement</u> encouraging Christians to join in daily prayers for the King and the nation.

They said:

"The forthcoming Coronation of King Charles III is a moment of great importance and joy for this nation.

As Presidents of CTE, we invite Christians from all traditions to join together in a period of daily prayer, for both the King and the nation, from Easter Day through to 6 May.

We welcome the publication by the Church of England of the book of Daily Prayers for the Coronation of King Charles III which can be used as a guide to reflection. The Coronation will be a time to celebrate community, faith and service – values that are reflected in these prayers."

The Daily Prayers

The book of prayers, produced by the Church of England combines themed daily readings and shares features of the Coronation Ceremony, exploring the Christian symbolism behind it.

The readings also reflect the value that King Charles III places on charitable work, environmentalism, volunteering and community life.
