Opening Reflection by the Revd Geoffrey Clarke

Container or Content?



Unfortunately, most people get so preoccupied with their stable, and whether their stable is better than your stable, and whether their stable is the only "one, holy, catholic, and apostolic" stable, that they never get to the birth of God in the soul.

(Richard Rohr, Falling Upward. Published by SPCK. ISBN 978-0-281-06891-3)

I am conscious that some of our churches have re-opened for public worship, others are in the process of discerning and planning to do so and some have concluded that it still feels a fair way off before they can do so. And whether reopening is current, future or even unlikely there is a recognition that worship will "feel" quite different to that to which we are accustomed. Depending upon your preferences and convictions, it will be a cause for either relief or disappointment that there will be no congregational hymn-singing and services and sermons shorter in length. Similarly, by temperament or conviction, maintaining "physical distance" and minimising socialising before, during or after worship will be a gain or loss. This unasked-for situation enables us to reconsider what is essential for us – as individuals and as worshipping communities.

And this is where I found **Richard Rohr**'s words so helpful. He urges us to distinguish between "the stable" and "Jesus" and highlights the very real risk that we can be so distracted with the former that we overlook the latter. In our current challenge we need to discern whether the sanctuaries of our church buildings and the full content of our liturgies are "the stable" and where and what might suffice for, and I quote, "Christ (to) be born". Rohr continues, "There is no indication in the text* that Jesus demanded ideal stable conditions; in fact, you could say that the specific mentioning of his birth in a "manger" is making the exact opposite point. Animals at least had room for him, while there was "no room for him in the inn" (Luke 2:8) where humans dwelled." (*The best biblical scholars will, of course, point out that there is no reference to "stable" in the texts either. Our use of it – and Rohr's – is itself highlighting what we superimpose on to the basics of the gospel!)



Speaking personally, I have been both impressed by and grateful to all whose skills and creativity have enabled worship to be sustained throughout the period of church buildings being locked. I know that some have had a "crash course" in livestreaming, creating videos, using **Zoom** et al. Hours have been devoted to creating and circulating worship resources for those who don't use the internet. I have shared in the challenge and experience of preaching and leading worship that has been recorded and shared as well as "live" via Zoom. (I must be the first East Midlands Synod Moderator able to preach at both Matlock in Derbyshire and Harrold in Buckinghamshire at the same time!) Rohr helps us assess what is stable-focused and what is Jesus-focused. In short, what is "container" and what is "content".

I was also challenged by **Dr Sara Parvis**, one of the contributors to the Webinar hosted by the Society for Ecumenical Studies on "**Communion in the Light of Covid-19**" (sponsored by Reform and The Tablet). Dr Parvis is Senior Lecturer in Patristics at the University of Edinburgh and a practising Roman Catholic. Responding to the criticism of some that churches had been closed and people prevented from attending Mass – labelled by some as "the eucharistic fast scandal" – she suggested that lockdown had "stripped down for us as disciples" the question as to where we receive Christ and where we serve him. She proposed that "laying down the life of the church" to go into lockdown (Roman Catholics depriving themselves of the presence of Christ in Holy Communion) was akin to Jesus' challenge, "*No one has greater love than this, to lay down one's life for one's friends*" (John 15: 13). "Church services with singing and Communion are super-spreading occasions," she said. Remaining closed, therefore, is a sacrificial act, laying down the Church's life for the good of others. Her words might be of consolation to those of our own churches who as yet do not feel it is safe to open their doors.

May God guide our thinking and decision-making – and be praised in our worship and living, however different that might be in content.

Practical Guidance for Churches

Procedure for reopening churches

The Synod's **Ordained Ministries & Churches Group (OMCG)** has laid out its recommended steps for reopening church buildings. Please note the following stipulations **before** reopening:

- 1. The Elders are the "venue managers" and have responsibility for the decisions regarding reopening of church premises.
- The Elders should consider the guidance in the URC's "Emerging into the New Normal" on the
 National website
 (https://urc.org.uk/images/Communications/docs/Emerging into the new normal.pdf), together
 with any additional information such as the Use of Face Coverings added on 16 July (see below).
- 3. The Elders should carry out a **Risk Assessment** using the form on the National website: https://urc.org.uk/images/images/URC Risk Assessment Template Updated.pdf
- 4. The Elders should then consider what **new signage** is needed and what **new policies** need to be in place to safeguard all users of the premises.
- 5. **All users** of the premises need to be informed of these new policies and the need to conform to them.
- 6. Once satisfied that the premises are safe to reopen the Elders then **sign the form** in the National guidance and **record the decision** in the Minutes of the Elders Meeting.
- 7. This may be a **phased return** to use, with opening for private prayer and worship the priority.
- 8. Once the decision has been made for reopening **the Synod Property Officer should be informed** of the relevant date. In the East Midlands Synod, please contact **Mr Geoff Milnes** on property@urc5.org.uk.

In light of evolving government guidance, the **Synod Moderators** have updated their advice to encourage the use of face coverings for all people attending worship and any other face-to-face events within the URC. Their guidance includes:

- alternative suggestions for those leading worship
- other possible exclusions and suggestions for providing masks where appropriate
- the avoidance of removing or otherwise touching face coverings during worship



Security Funding Scheme

Churches are reminded that applications to the government's **Places of Worship (POW): protective security funding scheme** close on Sunday 9 August 2020. This is designed for places of worship and associated community centres etc who may be vulnerable to vandalism or other hate crimes. To date 180 places of worship around the UK have been awarded grants to install measures such as protective alarms, security lighting and access controls.

Stepwise in South Wigston

<u>Stepwise</u> – the URC's new discipleship development programme – has been pioneered in the East Midlands Synod by a group from **South Wigston URC**. The group has recently completed the **Faith-filled Life** stream and we are delighted to send them our congratulations. The following account of their Stepwise journey is shared by the church's Secretary **Di Statham**.



When **South Wigston URC** received the initial "leaflets" publicising the **Stepwise** course we were not sure if it was for us. For all of us it was "a few years" since we had been involved in any serious study or learning. Could our brains cope with something which would take months to complete? But we thought and prayed about it and invited **Jane Henderson** to come and talk to us face to face. After much thought (and encouragement from our Minister **Revd Richard Eastman**) we agreed to go ahead with Revd Eastman as our Facilitator. We knew that with just 4 of us plus Richard taking part it would be a small group but that also meant that it was easier to arrange our Group Sessions on a date when we could all attend. So we registered our interest and received our login details so that we could access the course material.

Despite receiving all of the information I do not think that initially any of us really understood what the course entailed and what was expected of us. Our first meeting with our Mentor, **Revd Samuel Silungwe**, after Group Sessions 1 & 2 made us realise that we were not getting as much as we could from the personal study and group sessions. So we decided to go back and start again with a renewed understanding on all of our parts. Each session gave us something to look at and study for ourselves and then bring to our Group Sessions. I admit that sometimes I had to "force myself" to sit down and look at the readings or video for a session but once I had taken that step I felt ready to go to the Group Session with "something to say". It may have been because we were a small group or because we already knew and felt comfortable with each other but we all joined in with the discussions and were happy to put forward our ideas, even if they were

different to those of somebody else in the group. As a result we all learnt more about ourselves and each other.

Throughout the course we received support from our Facilitator (Revd Richard Eastman) and our Mentor (Revd Samuel Silungwe) and we were encouraged to think for ourselves. Now we have completed all six sessions we need to think about the future. At the moment we are not sure about our next step but this first stage has given us all an opportunity to look at our own discipleship and our place in the community around our church. I am sure that the work we have done so far will be valuable to us as we move forward. Thank you to all of those who have been involved with our Stepwise Group for their participation, support and guidance.
