Bless the Lord , O my soul.  
You make springs gush forth in the valleys;  
They flow between the hills,  
Giving drink to every wild animal;  
The wild asses quench their thirst.  
By the streams the birds of the air have their habitation;  
They sing among the branches.  
From your lofty abode you water the mountains;  
The earth is satisfied with the fruit of your work.  
Psalm 104 v.1, 10-13 NRSV

These refreshing words are part of a much longer psalm that celebrates the greatness of God as shown through the natural world. Starlit heavens, high mountains and valleys, grass and plants providing food and wine, wild animals going about their hunting by night, birds nesting in tall trees, the sea full of 'creeping things'.

We know all about the billions of years during which the earth as we know it today was formed; the moving of tectonic plates in the earth pushing continents apart. We have looked in amazement at long dead creatures - vast dinosaurs which once roamed the earth whose bones now lie buried in stone; we've followed the trail of evolution which leads to a myriad of life forms - insects and birds, animals, reptiles and fish, which inhabit the earth today.

As Christian people we do not deny evolution or pretend that the earth did not take eons to form and is in a continuous process of change, but we look beyond these things to God the creator. We do so in wonder and in worship, in hymns and psalms that celebrate God's abundance, God's gift of this earth and God's gift of life.

How are we to respond? Do we accept the gift, treasure it, look after it, use it wisely? Or do we trash it, trample on it, destroy it? As we struggle through a heatwave, sweeping as far north as the Arctic and as far east as Japan, scientists tell us that this is only to be expected. It's part of the effect of climate change. And although climate change happens naturally, we know our present runaway heating up of the earth is caused by human activity. So we are trashing the gift! As Christian people, knowing we are loved by the Creator God, we have to take responsibility - to care for the environment, to use its resources wisely, to love and not destroy.

In 2016 General Assembly approved the URC's Environmental Policy and committed the church to implementing it. In our churches we can use the resources and accept the challenge provided by Eco-Church. In a few weeks time you will hear about Green Journey, offering help to all our churches in the management of our buildings, which will be promoted by our Green Apostle, Charles Jolly. What can your church do, what can you do, to make our commitment to the stewardship of God's earth real?

## GDPR - GENERAL DATA PROTECTION REGULATIONS

### Visit to the Synod Office

At our invitation, an officer from the Information Commissioner's Office made an advisory visit to the Synod Office at the end of July. He looked through our documentation and asked us various questions about how we are implementing data protection. He praised Synod's good practice in a number of areas and made some recommendations for improvement. Remembering the hours of hard work staff put in, how good it was to read: "The staff and volunteers who are involved and responsible for the implementation of GDPR are clearly well motivated, engaged, and interested."

### Does it apply to my church?

There are a couple of things to draw to the attention of local churches. Firstly, GDPR applies to all organisations, including local churches. Do not believe anyone who tells you it does not. The officer drew our attention to a recent judgement of the European Court of Justice confirming that religious organisations are not exempt from the Regulation. If you have not yet done so, download the templates from the Synod website, which you will find on the GDPR button on the home page: [www.urch5.org.uk](http://www.urch5.org.uk) and adapt them for your church. If you need any help, please ring the Synod Office, and the privacy officers, Hannah Holmes and Hannah Willey, will help you.

### CCTV

**Secondly, do you have CCTV on your premises?** If so, you must register with the ICO. Go to the ICO website, [www.ico.org.uk](http://www.ico.org.uk), click on 'Pay fee, renew fee, or register a DPO'. The fee for charities is £40 annually, so not excessive. All churches may find it helpful to go through the self-assessment check list on that page to check whether you need to register with the ICO. Our view is that as 'not-for-profit' organisations, you do not (unless you have CCTV), but please make your own decision about this. There are updates to GDPR in preparation. We will let you know through the E-letter if there is anything local churches need to know.
